ENACTING AN ORDINANCE AMENDING SECTION II OF MUN.
ORD. NO. 07, S. 1997 OTHERWISE KNOWN AS "FIXING THE
FARE OF TRICYCLES PLYING THE POBLACION - TUBAN ROUTE,
THIS MUNICIPALITY"

WHEREAS, the last approved tariff of tricycles plying the Poblacion route to all points of Tuban, this municipality, was approved in 1997 and has not been updated;

WHEREAS, there is a need to amend Section II of the aforementioned ordinance considering that frequent price hike on oil/fuel/gasoline happened within the years passed;

WHEREFORE, on motion of Hon. Felipe M. Omblero, duly seconded by Hon. Robert Bellarmine R. Bajo, it was

RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Sta. Cruz, assembled in session to amend Section II of Mun. Ord. No. 07, s. 1997, otherwise known as "Fixing the Fare of Tricycles Plying the Poblacion - Tuban Route, this municipality".

AMENDING SECTION II OF MUNICIPAL ORDINANCE NO. 07,
S. 1997 OTHERWISE KNOWN AS "FIXING THE FARE OF

Be it ordained by the Sangguniang Bayan of Sta. Cruz, in session assembled that:

SECTION I - That there shall be an amendments to Section II of Mun. Ord. No. 07, s. 1997;

SECTION II - That Section II, Schedule of Fare Rates be amended as follows:

A. For Regular Passengers:

Pob./Pub. Market to Sitio Guma, Pub. Cemetery and v-versa	-----P3.00
Pob./Pub. Market to Crossing Battalion, Subida and v-versa	----- 3.50
Pob./Pub. Market to Crossing Tuban, Crossing Melilla and vice-versa	----- 4.00
Pob./Pub. Market to Baliwaga and vice-versa	----- 6.00
Pob./Pub. Market to Sitio Curasi and vice-versa	----- 6.00
Sitio Baliwaga to Sitio Curasi and vice-versa	----- 6.00
Sitio Baliwaga to Crossing Tuban, Crossing Melilia and vice-versa	----- 3.00
Sitio Baliwaga to Crossing Battalion, Pub. Cemetery and vice-versa	----- 4.00
Sitio Baliwaga to Sitio Guma and vice-versa	----- 5.00


B. For Student/Senior Citizen Passengers:

Pob./Pub. Market to Sitio Guma, Pub. Cemetery and v-versa	-----P2.50
Pob./Pub. Market to Crossing Battalion, Subida, Crossing Tuban, Crossing Melilia and v-versa	----- 3.00
Pob./Pub. Market to Sitio Baliwaga and vice-versa	----- 3.50


SECTION III - This amendment shall take effect ten (10) days after its approval and posting in three (3) conspicuous places in the municipality.
