**ENACTING A MUNICIPAL ORDINANCE CREATING TASK FORCE  
OPLAN KALULUWA DURING THE YEARLY CELEBRATION OF ALL  
SOULS DAY AND ALL SAINTS DAY IN THE MUNICIPALITY OF STA.  
CRUZ, DAVAO DEL SUR**

**WHEREAS**, every 1<sup>st</sup> and 2<sup>nd</sup> day of November of the year, the Filipino Christian community celebrates All Souls Day and All Saints Day where our Christian constituents pay homage to their departed love ones in cemeteries;

**WHEREAS**, it has been observed that during this yearly celebration, there were unavoidable incidents that lead to possible crimes or offenses;

**WHEREAS**, in order to prevent/avoid this kind of circumstances and to protect the welfare of the general public, it is but necessary to assign personnel who will man the cemetery and its vicinities and extend assistance to the visiting public in the municipal cemetery at Tuban, Sta. Cruz, Davao del Sur and other cemeteries in the barangay;

**WHEREFORE**, on motion of Hon. Alan B. Angub, unanimously seconded, it was

**RESOLVED**, as it is hereby resolved by the Sangguniang Bayan of Sta. Cruz, assembled in session to enact the following:

**MUNICIPAL ORDINANCE NO. 11**  
Series of 2004

**CREATING TASK FORCE “OPLAN KALULUWA”  
DURING THE YEARLY CELEBRATION OF  
ALL SOULS AND ALL SAINTS DAY  
IN THE MUNICIPALITY OF STA. CRUZ**

Be it ordained by the Sangguniang Bayan of Sta. Cruz, Davao del Sur, in session assembled that:

**SECTION 1 - CREATION.** There shall be created Task Force Oplan Kaluluwa during the yearly celebration of All Souls and All Saints Day in the Municipality of Sta. Cruz, Davao del Sur;

**SECTION 2 - COMPOSITION.** The Task Force Oplan Kaluluwa shall be composed of the following:

1. Sta. Cruz PNP Personnel
2. Municipal Mayor's Office Personnel
3. Officers and Members of SAVERS
4. Municipal Health Personnel
5. Municipal Engineering's Personnel

**SECTION 3 - DUTIES AND FUNCTIONS.** The Task Force "Opan Kaluluwa" shall have the following functions and duties, to wit:

1. To maintain peace and order during the celebration and prevent the occurrence of any possible crimes or offenses;
2. To extend assistance to all people who will visit their departed love ones in the cemeteries;
3. To establish a Police Assistance Center in the cemetery and other cemeteries in the barangay;
4. To regulate the traffic rules and regulation within the vicinity of the cemeteries
5. To prohibit drinking sprees, gambling and other illegal activities in the cemetery and its vicinities;
6. To submit report to the Office of the Mayor and Sangguniang Bayan after the celebration.

**SECTION 4 - EFFECTIVITY.** This ordinance shall take effect immediately upon approval
