**ENACTING AN ORDINANCE PRESCRIBING NEW RENTAL
RATE FOR THE USE OF THE MUNICIPAL GYMNASIUM
OF STA. CRUZ, DAVAO DEL SUR**

WHEREAS, the Municipal Gymnasium of Sta. Cruz has been utilized for years in the conduct of any group activities such as conferences, meetings, symposia, entertainment and cultural shows and other wholesome activities;

WHEREAS, proceeds from the existing rentals for the use of the said facility can no longer sustain for its maintenance and payment of electrical consumption;

WHEREAS, due to rapid peso devaluation, there is a need to increase the rental rates of the said facility;

WHEREFORE, on motion of Hon. Raul D. Duhaylungsod, unanimously seconded, it was

RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Sta. Cruz, assembled in session to enact the following:

**PRESCRIBING NEW RENTAL RATE FOR THE USE OF THE MUNICIPAL
GYMNASIUM OF THE MUNICIPALITY OF STA. CRUZ, DAVAO DEL SUR**

Be it ordained by the Sangguniang Bayan of Sta. Cruz, in session assembled that:

SECTION 1 - There shall be prescribed a new rental rates for the use of the Municipal Gymnasium of the Municipality of Sta. Cruz, Davao del Sur;

SECTION 2 - The prescribed new rental rate shall be as follows:

- a.) For usage in the morning (6:00AM – 5:00PM) - P 500.00
- b.) For usage in the afternoon (5:00PM – 12:00 MN) - 1,000.00

SECTION 3 - That upon application/registration, payment shall be paid to the Municipal Treasurer or to his/her duly authorized representative;

SECTION 4 - That any programs or activities conducted by educational, charitable, religious and government institutions free to the public shall be exempt from the payment of the fee herein prescribed, provided that the corresponding Mayor's Permit shall be secured accordingly.

SECTION 5 - Any ordinance or provision thereof which is inconsistent with the provisions of this ordinance is hereby modified, repealed or amended;

SECTION 6 - This ordinance shall take effect 15 days after posting to conspicuous places of this municipality.
