**ENACTING AN ORDINANCE AMENDING SECTION 4 OF  
MUNICIPAL ORDINANCE NO. 03, SERIES OF 2012 RE: AN  
ORDINANCE CREATING THE MUNICIPAL QUARRY AND  
DESILTING OPERATION MONITORING TEAM WITHIN THE  
MUNICIPALITY OF STA. CRUZ, PROVINCE OF DAVAO DEL SUR**

**WHEREAS**, the previous Council of the Sangguniang Bayan of Sta. Cruz, Davao del Sur enacted Municipal Ordinance No. 03, s. 2012 which creates the Municipal Quarry and Desilting Operation Monitoring Team within the Municipality of Sta. Cruz, Province of Davao del Sur;

**WHEREAS**, such enacted was made by the previous Council to support the existing mechanism of the Provincial and National government agencies in monitoring quarry operations, ensuring that laws and ordinances are complied with and help in evaluating the effects of quarry operation in the environment, public safety and over-all economic development of this municipality;

**WHEREAS**, recently, Municipal Engineer Azucena M. Buquia, leader of such quarry monitoring team, requesting/appealing the Local Chief Executive (LCE) thru the Sangguniang Bayan to amend the composition of such team on the ground that she cannot act/fulfill her functions due to her workloads as a Municipal Engineer/Building Official and BAC Chairperson;

**WHEREAS**, after thorough discussions and deliberations of the above-cited request, the members of the August Body present recommended for the amendment of such ordinance on account of the reasons stipulated in the request of the team leader;

**WHEREFORE**, on motion of Hon. Fernando C. Ugdoracion, unanimously seconded by the members present, it was

**RESOLVED**, as it is hereby resolved by the Sangguniang Bayan of Sta. Cruz, Davao del Sur, assembled in session to enact the following ordinance:

**AMENDING SECTION 4 OF MUNICIPAL ORDINANCE NO. 03,  
SERIES OF 2012 RE: AN ORDINANCE CREATING THE  
MUNICIPAL QUARRY AND DESILTING OPERATION MONITORING  
TEAM WITHIN THE MUNICIPALITY OF STA. CRUZ, PROVINCE OF  
DAVAO DEL SUR**

Be it ordained by the Sangguniang Bayan of Sta. Cruz, Davao del Sur, in session assembled that:

**SECTION 1** - There shall be amendment to Section 4 of Municipal Ordinance No. 03, s. 2012 re: An Ordinance Creating the Municipal Quarry and Desilting Operation Monitoring Team within the Municipality of Sta. Cruz, Province of Davao del Sur;

**SECTION 2** - That Section 4 of said municipal ordinance be amended and shall be read as follows:

SECTION 4 - Composition. The Monitoring Team shall be composed of the following:

Team Leader: MENRO-Designate  
Members : Municipal Planning and Development Coordinator  
Licensing Officer  
Municipal Engineer  
Municipal Treasurer

Each member of the team may designate a permanent alternate representative to represent them in any activity or meeting of the Monitoring Team.

**SECTION 3** - That all other provisions of Municipal Ordinance No. 03, series of 2012 which are not affected by this amendment shall remain in full force and effect.

**SECTION 4** - This amendatory ordinance shall take effect immediately after its approval.
