**ENACTING A MUNICIPAL ORDINANCE FIXING THE NEW FARE
OF TRICYCLES PLYING THE POBLACION ZONE III –
CORONON/NUERE COMPOUND (NORTH BOUND ROUTE) IN
THE MUNICIPALITY OF STA. CRUZ, DAVAO DEL SUR**

WHEREAS, the Officers and Members of the North Sta. Cruz Tricycle Operators and Drivers Cooperative (NSCTODCO) thru its Chairman, Mr. Nawadel Ajal, respectfully requested the Local Chief Executive (LCE) for a fare increase for tricycles plying the north bound route;

WHEREAS, such petition-letter of the NSCTODCO was indorsed by the LCE to the Body for consideration and appropriate action and the same was referred to the Joint Committee on Rules and Committee on Public Transportation for public hearing;

WHEREAS, the joint committees, after the conduct of public hearing and/or consultation with the riding public and some NGOs, had recommended for its approval considering the frequent oil price hike and its spare parts;

WHEREFORE, on motion of Hon. Alan B. Angub, unanimously seconded, it was

RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Sta. Cruz, assembled in session to enact an ordinance Fixing the New Fare of Tricycles Plying the Poblacion Zone III – Coronon Route, to wit:

**FIXING THE NEW FARE OF TRICYCLES PLYING THE
POBLACION ZONE III – CORONON/NUERE COMPOUND (NORTH
BOUND ROUTE) IN THE MUNICIPALITY OF STA. CRUZ, DAVAO
DEL SUR**

Be it ordained by the Sangguniang Bayan of Sta. Cruz, Davao del Sur in session assembled that:

SECTION 1 - There shall be imposed a new fixed rate of fare for tricycles plying the Poblacion Zone III to Barangay Coronon/Nuere Compound, Sta. Cruz, Davao del Sur”;

SECTION 2 - The new rates shall categorically be imposed as follows:

SECTION 3 - That anybody caught violating this ordinance shall be meted a penalty, to wit:

1 st Offense	-	P1,000.00
2 nd Offense	-	1,500.00
3 rd Offense	-	2,500.00 and revocation of MTOP (in case of drivers/operators)

SECTION 4 - Any other ordinance inconsistent with this ordinance or with any of its provision is hereby repealed, modified or amended.

SECTION 5 - This ordinance shall take effect fifteen (15) days upon its approval and posting in three (3) conspicuous places in the municipality.
