**ENACTING AN ORDINANCE AMENDING SECTION 2 OF
MUNICIPAL ORDINANCE NO. 14, SERIES OF 2013,
AMENDING FURTHER SECTION 4 OF MUNICIPAL
ORDINANCE NO. 13, SERIES OF 2011 RE: PRESCRIBING
GUIDELINES ON THE GRANTING OF CASH GIFT FOR JOB
ORDER EMPLOYEES IN THE LOCAL GOVERNMENT UNIT OF
STA. CRUZ, DAVAO DEL SUR**

WHEREAS, in 2013, Mun. Ordinance No. 13, s. 2011 has been amended by Mun. Ordinance No. 14, s. 2013 to set new guidelines in the granting of cash gift to job order employees amounting to Php500.00 per month;

WHEREAS, it the recently approved Supplemental Budget No. 05 of the LGU-Sta. Cruz, it was agreed by the executive and the legislative that an amount of Php666.67 per month as allowance shall be given to job order employees of this municipality;

WHEREAS, there is a need for the August Body to amend such municipal ordinance to harmonize with the approved budget allocation intended for the allowance of job order employees;

WHEREAS, after thorough discussions and deliberations, the members of the August Body present favored of amending the guidelines provided in the said municipal ordinance in order to provide benefits to job order employees which they deserve to receive in due recognition to their services rendered to this locality;

WHEREFORE, on motion of Hon. Fernando C. Ugdoracion, unanimously seconded by the members present, it was

RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Sta. Cruz, Davao del Sur, assembled in session to enact the following:

**AMENDING SECTION 2 OF MUNICIPAL ORDINANCE NO. 14,
SERIES OF 2013, AMENDING FURTHER SECTION 4 OF
MUNICIPAL ORDINANCE NO. 13, SERIES OF 2011 RE:
PRESCRIBING GUIDELINES ON THE GRANTING OF CASH
GIFT FOR JOB ORDER EMPLOYEES IN THE LOCAL
GOVERNMENT UNIT OF STA. CRUZ, DAVAO DEL SUR**

Be it ordained by the Sangguniang Bayan of Sta. Cruz, Davao del Sur, in session assembled that:

SECTION 1 - There shall be amendment to Section 2 of Municipal Ordinance No. 14, s. 2013, amending further Section 4 of Municipal Ordinance No. 13, s. 2011 re: Prescribing Guidelines on the Granting of Cash Gift for job order employees in the Local Government Unit of Sta. Cruz, Davao del Sur;

SECTION 2 - That Section 2 of Municipal Ordinance No. 14, s. 2013 is hereby amended to be read as follows:

Section 4. Guidelines. There shall be granted an Allowance of Php666.67 per month or fraction thereof to each personnel of the LGU-Sta. Cruz hired on a job order basis who has rendered services until December 31 of the current year.

SECTION 3 - That all other provisions of Municipal Ordinance No. 13, series of 2011 which are not affected by this amendment shall remain in full force and effect.

SECTION 4 - This amendatory ordinance shall take effect immediately after its approval.
